Falun Gong Practitioners in Tangshan City Injected with Toxic Drugs

(Clearwisdom.net) During the past eleven years of persecution, the Chinese Communist Party (CCP) has employed a number of methods to try to force Falun Gong practitioners to give up their belief. Among the most heinous tactics is the use of toxic drugs. In Tangshan City, detained Falun Gong practitioners were sent to Ankang Hospital (a mental hospital being used for the persecution of Falun Gong) where they were injected with drugs that damage the central nervous system. A variety of drugs are being used, with the aftereffects of the injections differing from person to person.



Ni Yingqin

Ms. Ni Yingqin is from the Kaiping District. She went to Beijing to appeal for justice for Falun Gong on August 22, 2000. She was illegally arrested and admitted to the Kanshan First Detention Center, where she was forced to run outside wearing shackles. She was held in solitary confinement, was shocked with electric batons, and was force-fed. After Ms. Ni was taken to Ankang Hospital and given injections of unknown drugs, she could not walk anymore or grasp anything with her fingers. She developed severe neurological problems, including seizures, and heart problems.



Shang Shiyang

In October 2000, Ms. Shang Shiyang was sent to the Tangshan City First Detention Center. She was held in solitary confinement, forced to wear shackles, forced to sit on an iron chair (a torture device), and was not permitted to use the restroom. After she held a hunger strike to protest this mistreatment, Ms. Shang was transferred to Ankang Hospital in Tangshan City. There, she was injected with unknown drugs, which left her in great pain. She was disoriented and unable to move her eyes or tongue. Ms. Shang was arrested again on January 14, 2010, and is still being held in the Fengnan Detention Center.



Li Fengzhen

Ms. Li Fengzhen, in her 50s, was taken away by the police, including Li Fuguo and Wang Min from the Tanghai County Police Department, on June 10, 2010. She was transferred to Ankang Hospital on June 25. In the hospital, Ms. Li was injected with unknown drugs against her will. In only two months, the once healthy and completely rational Li Fengzhen basically lost her memory. She became emaciated and mentally unstable. She could not see clearly, nor could she stand upright or walk. Ms. Li had pain in the left side of her chest, and she was no longer able to take care of herself.

Introduction to Falun Dafa

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. Introduced by Mr. Li Hongzhi in China, the practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-Forbearance in daily life. Falun Gong is not only beneficial to one's own health and well-being, it also benefits others. Although the practice originated in China, today it is practiced throughout the world by people of all races and walks of life. CCP Delegate Publicly Admits to Persecution of Falun Gong at UN General Assembly

(Clearwisdom.net) United Nations Special Rapporteur on Freedom of Religion or Belief, Professor Heiner Bielefeldt spoke out against the Chinese Communist Party's (CCP) persecution of Falun Gong on October 21, 2010, at the UN General Assembly at the UN Headquarters in New York. A Chinese delegate responded by calling Falun Gong an "evil cult," and stated that the CCP's intent and policy was to "eradicate" Falun Gong. He further claimed that the Chinese government's policy of persecuting Falun Gong practitioners was correct.

It is rare that a CCP delegate would admit that the persecution exists or acknowledge the severity of the persecution openly to the international community. The delegate clearly stated that Falun Gong practitioners must be "punished severely" and "eradicated." His response completely exposed the hypocrisy of the CCP's long-advertised policy of so-called "care, love, transformation, and education" of Falun Gong practitioners.

Lung Cancer Patient Sees Hope

(Clearwisdom.net) I am Wang Lu, from a village in Jiazuo City, Henan Province. I'm 46 years old. I've directly benefited from and experienced the wonderfulness of Falun Dafa. Falun Dafa saved my life.

During the summer of 2009, I was running a low fever for a long time and wasn't able to eat. I had a dull pain in my chest and had lost much weight. The pain in my chest became more severe, so I went to a hospital for an examination. The doctor said that the result from the CT scan indicated that there were two holes in my lungs and I had advanced lung cancer.

I became desperate. My entire family was sad and very worried about me. On the way home from the hospital, I was in deep thought and couldn't understand why I developed this incurable disease. I've never done anything that harmed others. When I was feeling hopeless and about to give up on treatment, my sister, who is a Falun Dafa practitioner, heard about my situation. She quickly came to see me and told me that all her diseases had disappeared after she started to practice Falun Dafa. Gradually, as I read, I fell asleep. I dreamed that a tall, kind and gentle man approached me. He reached his hand into my chest, grabbed a handful of tissue and took it out. I felt pain in my chest and screamed. Then I woke up. It was around 2 a.m. My wife was awakened by my screaming. She found me drenched in sweat, and asked what had happened. I said I was very hungry and asked her to cook some food. I ate four packs of instant noodles and four eggs.

Later, I went to the hospital for another examination. The doctor was very surprised because the two holes in my lungs were gone. I was so excited I cried. There are no words that could express my gratitude to Falun Dafa for saving my life.

From then on, I tell every person I meet, "Falun Dafa is good! Falun Dafa saved my life!" Here, I hope that everyone, especially people in China, will no longer be deceived by the lies of the Chinese Communist Party. I would like everyone to know that Falun Dafa is great!
