Witnesses Testify about the Chinese Communist Party's Atrocities of Harvesting Organs from Living Falun Gong Practitioners

(Clearwisdom.net) On April 20, 2006, Falun Gong practitioners held a press conference and rally at McPherson Square while President Bush was meeting with Chinese President Hu Jintao nearby at the White House. Two witnesses of the Sujiatun Concentration Camp atrocities, Peter and Annie, made their first public appearance at the rally to testify on the abhorrent crimes of organ harvesting taking place in China.

In addition, it continues to tempt the international community with commercial interest and use terrorist measures to threaten witnesses, agencies and countries that wish to expose the facts about the Chinese Communist Party's (CCP's) practice of harvesting organ from living Falun Gong practitioners.

The two witnesses said that they felt they had to make the choice to use their lives as evidence to publicly expose the CCP's crimes.

A Possible Victim of Organ Harvesting

(Clearwisdom.net) Practitioner Ms. Tai Yurong, 36 years old, from Nanjia Village, Jiacun Township, Wangdu County, Baoding City, Hebei Province died as a result of persecution on December 19, 2001.

Ms. Tai was arrested on December 12, 2001, and was taken to the Wangdu County Raoci Garden. Tai Yurong went on a hunger strike to protest the illegal imprisonment and was mercilessly beaten and force-fed many times by people incited by Shang Hongzhi, Director of the 610 Office in Wangdu County (the 610 Office has been created solely to persecute Falun Gong). On the third day of Tai Yurong's hunger strike, she was taken to a hospital for an infusion; afterwards she was locked up in a room alone, and her two roommates (both Falun Dafa practitioners) were transferred to the room next door. Two days later, all of the other Dafa practitioners were moved to a room in the east end, and only Tai Yurong was left in the west end. On the seventh day after her arrest, December 19, Tai Yurong died.

When Tai Yurong's remains were at the Wangdu County Chinese Traditional Medicine Hospital, police from the 610 Office blocked off any access from the outside and refused to let Tai Yurong's family members and people from her village view her body. After her family members demanded to see her body, they were only allowed to look at Tai Yurong's face. When the family members wanted to look at her body, they were forcibly pushed out of the room immediately.

This raises many questions: Why was the family only allowed to view Ms. Tai's face and not the rest of her body? Was she beaten so badly that she had marks all over her body? Was she tortured in other ways that left clear physical signs as evidence? Had her organs been harvested? It is still unclear why the authorities would not let the family see the rest of her body.

Many questions remain unanswered.

I couldn't lift my arms because the tendons on both my shoulders were damaged. During the summer vacation of 2004, I also had high blood pressure

I still clearly remember that on the morning of November 20, 2004, I arrived at the Beichen Elementary School to learn the five sets of Falun Gong exercises.

It was a miracle that the first day after I finished practicing the exercises and returned home, my usual headache was already gone. I was so cheerful and excited. On the same day, I went to a bookstore to get the book, *Zhuan Falun* (the principal text of Falun Gong), and I read it from cover to cover. Each sentence touched my heart. I was moved very deeply.

After I practiced cultivation in Falun Dafa for a month, my agony of pain and swelling in the knees, being unable lift my arms, high blood pressure and shortness of breath were cured without my taking any medicine. I could walk or stand for two hours straight. I also could hold my hands up during the second set of exercises for the entire time without them falling down.
