Malpractice in Organ Transplant Center - Finding Matching Kidney in One Day

(Clearwisdom.net) The Falun Dafa Association and the Clearwisdom website established the "Coalition to Investigate the Persecution of Falun Gong" on April 4, 2006, and began collecting evidence of the recently exposed organ harvesting atrocities in China from many sources.

On May 17, 2006, an article entitled, "Transplanting Kidney Twice in 48 Hours, Patient Paid 220,000 yuan But Died" was published in issue 1562 of *Huaxia Times*. The article reported that Xue Yanlin from Fuyang, Anhui Province, was hospitalized in the Organ Transplant Center of Haidian Hospital and underwent a kidney transplant twice in 48 hours. Xue died 30 days after the surgery.

Han Xiuwu, the doctor in charge of Ms. Xue's surgeries, told our reporter, "Most kidneys come from the bodies of persons who voluntarily donated their organs when they were alive. To protect the privacy of the donors, we do not disclose their identities to patients and their families." The spirit of the donor is noble. Why would they require secrecy? The alarming thing is that only in the Chinese Communist Party's concentration camps has it been possible to match kidneys for transplant twice in 48 hours.

Xue's husband, Lu Xiaoxing sued the Organ Transplant Center in Haidian Court. He discovered that the Center had no license. The lawyer claimed that the activities of the Hospital constituted malpractice.

"Falun Dafa is Good" Parade in Chicago

The parade carried various messages for the audience, including "The World Needs Truthfulness-Compassion-Forbearance," "Stop Persecuting Falun

Gong," and "Open Investigation into Crimes of Harvesting Organs from Living Falun Gong Practitioners in Forced Labor Camps." The last section in the procession, "Global Support of Eleven Million Chinese People Quitting the CCP and Its Affiliated Organizations," was particularly relevant for the onlookers in Chinatown.

German Media Pays Attention to Practitioner's Arrest in China

(Clearwisdom.net) On June 15, 2006, the *People* newspaper of Leipzig, Germany carried an article entitled, "Her Life is Facing Danger," reporting on the wife of a Chinese student abroad who has been arrested and detained because she practices Falun Gong.

The article discusses Zhentong Zhang, who is from Dalian City in China and is now studying at Leipzig University of Germany. On May 27, 2006, Zhang's wife was arrested by policemen in front of her home because she practices Falun Gong. The policemen rushed into her home and confiscated her computer, printer, Falun Gong books and leaflets.

Mr. Zhang told the *People* of Leipzig: "Since 1999 when the persecution started, until now, my wife has been arrested three times. Her passport was confiscated, so she cannot come to Germany to visit me. Neither can I go back to see her. The persecution happening in China is, in fact, an action of severely trampling on human rights. The number of Falun Gong practitioners who have died as a result of the persecution has reached 2,898." Zhang is very worried about his wife's fate: "I know that her life is now at stake. In China, prisons and forced labor camps are hell on earth."

Falun Dafa Comes to a School Classroom in Denmark

(Clearwisdom.net) On June 21, 2006, serene music could be heard playing in the gymnasium of Bjerregrev School in the Danish town of Viborg. The teachers and parents watched with amazement their usually noisy children sitting quietly and doing the fifth exercise of Falun Gong, a sitting meditation.

This is part of the school curriculum teaching about the Chinese culture. The teachers invited Falun Gong practitioners to introduce the practice to the children. Practitioners taught the exercises, explained the principles of Falun Gong - Truthfulness-Compassion-Forbearance - to the children, and told them about the brutal persecution that's happening in China.

In the following two weeks, the teachers would lead the school children to do meditation for half an hour every day before classes began. They were amazed to find that the children would become quiet when they meditated, whereas they were usually very boisterous! Many adult participants asked for the bookmarks which provided details of the Falun Dafa websites, and expressed an interest in learning the practice.

More Persecution Cases in China

- On May 30, 2006, Ms. Wu Hong from Penglai City, Shandong Province, was arrested at her home and locked up in a brainwashing center controlled by the 610 Office (an agency specifically set up to persecute Falun Gong). On June 6, 2006, she was sent to Penglai City Hospital for emergency. She died on June 9, 2006. It is said that Ms. Wu Hong's skull was fractured. She was in a deep coma before her death, and relied on a breathing machine.
- Mr. Gao Qingcheng, 54 years old, was from Gaoxinzhuang and was an employee of the Tianjin Xinhe Shipyard. He was illegally detained in a forced labor camp for three years from February 2001 to February 2004. After he was released, he was still constantly harassed by government personnel. Mr. Gao was living under extreme mental pressure and died in March 2006.
- Ms. Tang Liyan, 36 years old, was a schoolteacher at the Linjiang Township Middle School, Tongjiang City, Heilongjiang Province. She began to practice Falun Dafa in 1998 and her illnesses went away. The local 610 Office and local police station often monitored and harassed her after the persecution began on July 20, 1999. She suffered a lot mentally and her health gradually deteriorated. She died on October 14, 2003.
