International Mainstream Media Focus on the CCP's Atrocities of Organ Harvesting

(Clearwisdom.net) On July 6, 2006, former Canadian cabinet member David Kilgour and international human rights lawyer David Matas released their 68-page investigative report entitled, "Report into Allegations of Organ Harvesting of Falun Gong Practitioners in China." The charges in the report against the Chinese Communist Party's (CCP) atrocities of live organ harvesting captured extensive attention from the mainstream media in the West. Media outlets including Reuters, AFP, Canadian Press, Canadian Broadcasting Company, *The Australian* and other mainstream media published reports on it the same day.

Reuters reported that respected Canadian human rights lawyer David Matas, and former Canadian cabinet member David Kilgour lent their weight on Thursday to charges that the CCP has been killing Falun Gong practitioners so it can use their organs. This is the conclusion they drew from their two-month investigation.

The report provided transcripts of phone calls placed to Chinese to detention centers and organ transplant clinics in which officials said organs from Falun Gong practitioners could be made available for speedy use. They also conducted interviews of their own and investigated government records and other evidence.

New Independent Report Concludes Falun Gong Organs Being Harvested, Victims Killed

(Falun Dafa Information Center) - A 68-page investigative report was released Thursday that addresses allegations of organ harvesting from Falun Gong detainees. Coauthored by former Canadian Secretary of State (Asia-Pacific) David Kilgour and human rights attorney David Matas, the report draws "the regrettable conclusion that the allegations are true."

Speaking with the press, Kilgour said on Wednesday, July 5, 2006 that, "I don't think anyone can have any doubt that this unbelievable practice is continuing... They take both kidneys, then the heart and the skin and the corneas and the liver, and your body is then thrown in the incinerator."

The report identifies the perpetrators specifically as "the government of China and its agencies in numerous parts of the country, in particular hospitals but also detention centers and 'people's courts'."

Where Are The Missing Falun Gong Practitioners?

(Clearwisdom.net) In the nearly seven years since the CCP started persecuting Falun Gong, Falun Gong practitioners have been continuously arrested and detained without legal reason. The number of detained practitioners is well into the hundreds of thousands. Many practitioners who went to Beijing to peacefully appeal refused to tell their names and addresses in order to resist the persecution. Furthermore, they did not want to implicate their employers, families and local officials. They were detained in secret and their whereabouts are unknown. It could well be they had their organs harvested before they could tell their names. The CCP declares these bodies as "unidentified" at cremation.

There are many reports of missing Falun Gong practitioners on the Clearwisdom website. Just two examples are listed here:

Mr. Zhang Wenliang, born in October 1945, was from Zunhua City, Hebei Province. In early November 2000, he went to Beijing to clarify the truth about Falun Gong but has not returned since.

Ms. Li Ruihuan, in her 60's, is from Shijiazhuang City, Hebei Province. Her address is 42-5-301, the Huaxing Neighborhood. On January 13, 2002, she went to Beijing to appeal on behalf of Falun Gong. The police arrested and savagely beat her and placed her in the Fengtai Detention Center. Ms. Li's whereabouts are unknown.

In light of the sharp increase in organ transplant surgeries performed since the persecution of Falun Gong began, and the number of missing practitioners, the source of the organs available for transplant in China is highly suspicious.

Certain Falun Gong practitioners in China have confirmed that a large group of practitioners from unknown location(s) have been recently transferred to the No. 1 Detention Center of Anshan City in Liaoning Province. The practitioners' names and hometowns are unknown. We are worried that they may become subjects of the illegal organ transplant industry.

Witnessing the Miracles of Falun Dafa

(Clearwisdom.net) In March 2005, my son was infected with hepatitis B, which could lead to an early stage of liver cirrhosis. He needed to be hospitalized for treatment. He was only 37 then, and he was scared to death. All indications on his liver were far from normal, and he had fever and looked physically weak. This was too much for him to endure. His doctor told me that there is no special drug for hepatitis B.

Accompanying my son to the hospital I said to him, "Now, only Falun Dafa can save you." He was feeling very bad because a 40-year-old man in his office just died of cirrhosis of the liver. The man's death had affected him considerably and he was very frightened. However, I said to him, "Everyone is different. As long as you have an upright mind, you'll definitely be alright, I'm telling you to do this: Every day you must sincerely, righteously, and silently recite, 'Falun Dafa is good, and Truth-Compassion-Forbearance is good' I am sure you will recover."

I also read to him some passages in Dafa books, such as "Sickness Karma" from *Essentials For Further Advancement*, as well as "The Issue of Curing Diseases" and "Hospital Treatment and Qigong Healing" in *Zhuan Falun* (the principal text of Falun Gong). Also, I had him listen to the tape recording of Master Li's nine lectures, and I showed him the standing exercises, including the first, third, and fourth exercises. I told him to just do whatever he could, because he was weak. But I emphasized that every day he must calmly and sincerely recite those few words in his mind. He promised to do so.

I went to see my son every week, and noticed big changes in him. The first week, I saw better color in his face, as opposed to the green color when he was first hospitalized. He had a negative reaction to an injection, with a high fever for three days, and was unable to get out of bed. His wardmate had to bring him water and help him with other things. The second time I went to see him, he could walk down from the third floor. The third time I saw him, he could come downstairs to walk around the garden a few times. When I saw him the fourth time, he could jog and even run. In April, my son was discharged from the hospital, and then in June he went back to work. I firmly believe that Falun Gong is responsible for his speedy and complete recovery.

Falun Dafa Practitioners Take Part in the Largest Independence Day Parade in the Western U.S.
