### **Persecution News from China**

# [Changchun City, Jilin Province] Practitioner Ms. Dong Shulan Illegally Arrested

On the morning of December 19, 2006, practitioner Ms. Dong Shulan and her family from Jilin City went to Heizuizi Women's Forced Labor Camp in Changchun City to visit Ms. Dong's daughter, Ms. Liu Hongxia. In the middle of a family meal, Lian Guangri, Head of Administration at the Heizuizi Forced Labor Camp, deceived Ms. Dong Shulan into going downstairs with him. He then handcuffed and arrested her. Ms. Dong Shulan is now being held at the No. 3 Criminal Police Division of the Chuanying Police Sub-bureau in Jilin City.

# [Baishan City, Jilin Province] Practitioner Mr. Xun Changping Sent to a Forced Labor Camp

Zhang Aimin, Head of the Fushun National Security Section, collaborated with Zhang Jianhua, Head of the Bashuihe Township Police Sub-bureau, in arresting practitioner Mr. Xun Changping and others on December 5, 2006. The practitioners are now being held at the brainwashing center of the Baishan City Police Academy.

After being detained in Fusong County, Xun Changping began to suffer from serious sicknesses. However, he was still sent to a forced labor camp for further persecution.

#### [Huanan County, Heilongjiang Province] Practitioner Mr. Renai Arrested

On the morning of December 20, 2006, Guo Junlin and three others from the Huanan County National Security Section arrested practitioner Mr. Guo Renai at his home. Mr. Guo, a primary school teacher, is being held at the Detention Center of the Huanan Forestry Bureau.

#### [Yilan County, Heilongjiang Province] Falun Gong Materials Production Site in Dalianhe Township Sabotaged; Practitioner Mr. Gong Fengqiang Arrested

On December 12, 2006, the Dalianhe Township Falun Gong materials production site in Yilan County was sabotaged. Mr. Guo Fengqiang, Mr. Xun Ren, Ms. Wu Shulian and a practitioner with the surname of Ma were arrested. Seven printers, a notebook, desktop computers, cash and a large amount of food were confiscated.

# [Shenyang City, Liaoning Province] Practitioner Ms. Yu Guizhi Arrested, Her Whereabouts Unknown

Practitioner Ms. Yu Guizhi, 67 years old, is from Shenyang City. She was arrested by policemen from the Huanghai Police Sub-station, Yuhong District on December 21. After having a medical checkup at the city hospital, her whereabouts are now unknown.

# [Changchun, Jilin Province] Practitioner Li Wei Has Been Sent to Changchun Police Hospital for Further Persecution

On December 8, 2006, practitioner Mr. Li Wei from Changchun City was arrested by police on Ziyou Boulevard, Changchun City and then sent to the Changchun City No. 2 Detention Center. Mr. Li went on a hunger strike to protest the persecution. On December 14 he was sent to the Changchun Police Hospital for further persecution.

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. Introduced by Mr. Li Hongzhi in China, the practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-

### Exposing Organ Harvesting from Falun Gong Practitioners During a Press Conference in Vienna

(Clearwisdom.net) On November 21, 2006, David Kilgour spoke during a press conference on human rights, arranged by the International Society for Human Rights (ISHR-IgfM) in Vienna. The press conference's purpose was to highlight the unimaginable human rights violations happening in China. Mr. Kilgour presented an investigative report that details illicit organ harvesting from Falun Gong practitioners in China. He spoke of human rights violations suffered by Falun Gong practitioners in China that are unimaginable to those living in the West. The investigative report, prepared by Mr. David Kilgour and Mr. David Matas, both well-respected Canadian human rights advocates, discloses that China conducts large-scale organ harvesting, where the organ sources are imprisoned Falun Gong practitioners.



### Hong Kong: Divine Land Marching Band from Taiwan Performs in New Years Day Parade

On January 1, 2007, the Service Center for Quitting the Chinese Communist Party (CCP) in Hong Kong and other organizations held a parade to support the 17 million withdrawals from the CCP. The Divine Land Marching Band from Taiwan, which was formed a few months ago, also came to perform.



Falun Gong practitioners and other attendees held banners to promote Falun Dafa and expose the CCP's brutality. Attendees also called for support for attorney Gao Zhisheng, persecuted by the CCP for calling for justice for Falun Gong.



### Practicing Falun Gong Cured My Many Illnesses, Including a Congenital Heart Defect

(Clearwisdom.net) I am a middle school teacher who is 62 years old. I had many illnesses before I began practicing Falun Dafa. For almost 26 years I had suffered from illnesses including a congenital heart defect, pulmonary tuberculosis, cervical vertebra ossein proliferation, Meniere's syndrome and an attachment to sleep. I had worn three pairs of special glasses for older people by the time I was in my early forties. Towards the end, everything was blurry when I read. I also had rheumatoid arthritis and other persistent illnesses.

I began Falun Dafa practice in January 1996. I did not need the special glasses for older people after I read *Zhuan Falun*, the principal text of Falun Dafa, three times. I could even see very small characters. All of my persistent illnesses disappeared after practicing, and my whole body felt light. From my childhood to the time before I started to practice, my lips were always white, having an inadequate blood supply due to my heart problems. I had always carried heart pills with me since the 1970's. After practicing, my lips looked as if they always had lipstick on them.

In March 2001, I was illegally arrested and held in the Dongcheng District Detention Center in Beijing, for going to Beijing to appeal for justice for for Falun Dafa. I went on a nine-day hunger strike in August 2004, to protest the persecution. Handcuffed and shackled, I was taken for a medical examination. The doctor looked at the ultrasound image for a long time, and also asked all the doctors working there to come and look at it. Finally, the doctor in charge said, "Practicing Falun Gong has filled up the gap in her atrium [*a chamber in the heart*]."

During the five years I spent in the forced labor camp, I was taken to the provincial hospital twice to have medical examinations. The first time was in August 2001, and the second time was in August 2004. The doctor who did the medical examination was the doctor in charge. He asked all the other doctors to come to his lecture. He said, "At noon these ten patients had damage to their hearts. This afternoon there is no damage. Practicing Falun Gong has truly healed their hearts."
