Ameena, who works in a bank, loves Chinese culture. Her husband is from Hong Kong, and they have traveled to Mainland China many times. Ameena and her husband responded positively to the dances about Falun Gong in the *Splendor*. One of her husband's relatives escaped China to avoid the Chinese Communist Party's (CCP) persecution. Ameena said that although the CCP will hold the Olympic Games, she knows that many people in China are still suffering badly, and subjected to illegal trials. Ameena had high praise for the show. She said it was wonderful, as it displayed the beauty of the Chinese culture. She thought the drum playing was particularly powerful.

Simpo Rora, a retired teacher in Brooklyn, said she was very impressed with the dance about the CCP's persecution of Falun Gong practitioners. ## Minghui School Students Perform at Tokyo Festival

(Clearwisdom.net) On the morning of January 27, 2008, Falun Gong practitioners in Tokyo and students from the Minghui School participated in a local festival in Meiji Park. At around 1:00 p.m., students from the Minghui School performed a traditional dance on the festival stage, accompanied by a song sung by a female practitioner. The audience applauded enthusiastically and many remarked, "They are so lovely."

Next, the Tianzi Dance Troupe performed "The Thousand Hands of Bodhisattva Guanyin," also to a receptive audience. After the dance, the practitioners demonstrated the five sets of Falun Gong exercises. When the exercise demonstration was over, the festival hosts came on stage and complimented the whole performance enthusiastically, expressing their regret at only being able to see it from the wings.

### Persecution-Related Deaths of 150 Falun Gong Practitioners Verified in 2007

(Clearwisdom.net) The deaths of 150 Falun Gong practitioners as a result of Chinese Communist Party persecution were verified through non-governmental channels in 2007. 123 of those deaths took place in 2007. Between July 20, 1999, and December 31, 2007, a total of 3,121 Falun Gong practitioners' deaths have been verified.

On October 15, 2007, the European Union and China were scheduled to hold a human rights dialog. Prior to the meeting, Vice President of the European Parliament Mr. Edward McMillan-Scott sent a letter to the Speaker of the European Parliament, Hans-Gert Poettering. In the letter, he mentioned that two thirds of those detained by the Chinese Communist regime are Falun Gong practitioners. Human rights attorney Gao Zhisheng concluded that about 250,000 practitioners are still being detained.

Mr. Wu Yueqing, a practitioner in his 30s, lived in Shuangyashan City, Heilongjiang Province. In June 2000, Mr. Wu was arrested and detained in the Tiebei Detention Center in Changchun City. The guards and the prison doctor stuck a water bottle down his throat and force-fed food into his trachea, causing his lungs to become infected. In December 2001, Mr. Wu was again arrested. He was sent to the Mudanjiang City Prison. During the detention, he was sick with tuberculosis and was severely underweight, at less than 80 pounds. Around the beginning of 2007, Mr. Wu returned home, close to death. His sister, Ms. Wu Yuexia, who is also a practitioner, looked after him. On September 28, 2007, police officers stormed into Ms. Wu Yuexia's home and took her to the Jiamusi City Labor Camp. Ms. Wu was her brother's only source of support. He died on December 23, 2007, leaving a 13-year-old child to live in an orphanage.

Another practitioner, Mr. Wu Jiuping, also in his 30s, lived in Tianchang City, Anhui Province. He was employed by the Tianchang City People's Hospital. At 4:00 p.m. on November 22, 2007, officers from the Tianchang City 610 Office and two police officers went to Mr. Wu Jiuping's home. Mr. Wu's neighbor on the first floor heard a loud noise outside and found Mr. Wu on the ground. The neighbor called for help and saw the four officers quickly leaving. A rescue worker rushed Wu to the Tianchang City People's Hospital. Soon after, about a dozen police officers sealed off Mr. Wu's home. Mr. Wu's bride-to-be and his family are all being closely monitored. Wu Jiuping died in the hospital at approximately 8:00 p.m. on November 22, 2007. Further investigation determined that after the police beat Mr. Wu on November 22 in his apartment, he was severely injured. The police then threw him from the fourth floor.
