### Mr. Huang Fujun's Family Seeks Justice

(Clearwisdom.net) Falun Dafa practitioner Mr. Huang Fujun lived in Acheng District, Harbin City, Heilongjiang Province. On July 24, 2007, he was arrested by policemen from the Songfengshan Town Station, and beaten until both of his feet were crushed and broken. The police detained him in the Acheng District First Detention Center and deprived him of his right to be visited for three months. Not until November 2, 2007, did the police notify Huang's family to come see him in the Acheng District Traditional Medicine Hospital, when he was dying.

Mr. Huang was unconscious, as thin as a skeleton, his face deformed from forced-feeding tubes, which were still inserted in his nose. Dried blood filled his nostrils; no one was sure for how long the tubes had been inserted. His buttocks were covered with terrible festering sores. Even in such a critical condition, his wrists and ankles were still handcuffed and shackled. Mr. Huang's family repeatedly requested that he be allowed to return home. The detention center administration finally released him, out of fear that if they kept him they would be held responsible for his death.

Mr. Huang was finally brought home on November 4, 2007. A 44-year-old man who was in good health was tortured to such a degree within only three months of being arrested. He could not talk or recognize people. At around 8:00 p.m. on November 6, 2007, his face turned pale, and he died, unable to say one word to his family before his death.

After Mr. Huang died, his family went to talk to the 610 Office chairman, Wang Xiaoguang. Wang promised that the funeral costs would be covered by Mr. Huang's employer, and his employer would give the immediate family employment since Mr. Huang was the main source of income for the household. Wang also promised that Mr. Huang's parents and child would receive some income security. Believing these promises would be kept, Mr. Huang's family agreed to let them ship his body to a funeral home. But soon after, police officers from the Acheng District Police Department surrounded their home, and did not allow the family access to Mr. Huang's body. None of the promises were kept, and the family received no compensation.

Under such terrible circumstances, Mr. Huang's family refused to sign the cremation paperwork, and they continued to request that an autopsy be performed. The police said the autopsy results would be issued after 45 days. During these 45 days, Mr. Huang's family hired a lawyer, requesting to be compensated 200,000 yuan and for the killers to be brought to justice.

Falun Dafa, also known as Falun Gong, is a practice for benefiting physical health and elevating the mind. Introduced by Mr. Li Hongzhi in China, the practice consists of five gentle exercises including meditation, and diligent effort on the part of practitioners to follow the universal principles of Truthfulness-Compassion-Forbearance in daily life. Falun Gong is not only beneficial to one's own health and well-being, it also benefits others. Although the practice originated in China, today it is practiced throughout the world by people of all races and walks of life. ## Los Angeles, California: Candlelight Vigil Held in front of Chinese Embassy to Commemorate Practitioners Tortured to Death in China

(Clearwisdom.net) On the evening of February 22, Falun Gong practitioners held a candlelight vigil in front of the Chinese Embassy in Los Angeles to commemorate their fellow practitioners tortured to death by the Chinese Communist Party (CCP). They also exposed the CCP's crime of killing millions of Chinese people since it took power in China.

Based on incomplete data from the Minghui/Clearwisdom website (at this time, it is not possible to determine the number of practitioners killed by the CCP in secret), the CCP has killed 3,128 practitioners in the brutal persecution of Falun Gong. The CCP's crime of organ harvesting from living Falun Gong practitioners, which was exposed in the beginning of 2006, indicates that the CCP's brutality and cruelty in the persecution are beyond people's imagination.

Falun Gong practitioners at the vigil expressed that the CCP's crimes against humanity hurt not only countless innocent Chinese people, but also people in free countries as well. They called on people of justice to step forward, condemn the CCP's atrocities, and rescue practitioners who are unlawfully imprisoned.

## Falun Dafa Healed My Fractured Leg

(Clearwisdom.net) *(By a practitioner in China)* I began practicing Falun Dafa in May, 2005. At that time, I could not walk because my leg had been fractured in a car accident. A Dafa practitioner encouraged me to learn the practice. He explained the facts about Falun Gong and exposed the persecution to me. I had an anxious desire to learn Falun Gong and wanted to read the related books. Until the government began persecuting Falun Gong in 1999, I had not heard of it or seen it before, yet every time I saw someone post a flyer or banner reading "Falun Dafa is good," I felt that Falun Gong must surely benefit people. Otherwise, why would people persist in practicing Falun Gong under the Chinese Communist Party (CCP) government's terrible persecution?

After several days, the fellow practitioner brought the book, *Zhuan Falun* (this book comprises the principal teachings of Falun Gong). I read the entire book non-stop, from 7:00 a.m. until close to 8:00 p.m. After I finished reading, I felt that the book teaches us to be good people. Many principles explained in the book, which I did not understand before, help people become generous and open-minded.

Why does the CCP not allow people to read such a good book? I soon read the book a second time. After reading, I wanted to learn Falun Gong. When the practitioner visited me again, I asked about the practice. Very quickly, the fellow practitioner got me a tape of exercise music for my practice, and I did the exercises that day on the bed.

The fellow practitioner also brought Master Li's other lectures to me. I eagerly emerged myself in Master's Law every day. My mood was light and expansive and my fractured leg did not hurt any more. It was true for me that once I finished one book I wanted to read another. Thus, I read almost all of Master Li's lectures at one time.

As the saying goes, it takes 100 days for fractures to heal, and I was already over fifty years old. Three steel pins had been inserted to hold the fractured bones together. After only two months of practicing Falun Gong, I had the pins taken out and was able to walk upstairs and downstairs. Dafa is so amazing, and is such a blessing. I received good fortune because of misfortune. If it were not for the traffic accident, I possibly would have learned another practice. So far, I have been practicing Falun Gong for more than two years. The rhinitis, arthritis, lumbago, convulsions and other ailments that I had prior to beginning the practice seemed to just disappear. I do not take any medicine and have been illness-free. Because of my experience, Falun Dafa's goodness has been made known to more people.
