The Death of Three Falun Gong Practitioners as a Result of Police Brutality

(Clearwisdom.net) On November 28, 2001, officer Zhang Huanyou arrested three Falun Gong practitioners from Yilan County for distributing materials exposing the persecution of Falun Gong. They were sent to different police stations. Each of these practitioners died as a result of abuse in police custody. The following are their stories.

1. Ms. Zhang Min - Han Yunjie from the Yilan Police Department handcuffed Ms. Zhang and hit her in the chest, eyes, and temples. After he slammed her head against a wall, Ms. Zhang started to cough up blood and became unconscious. Han poured cold water on her to wake her up and resumed beating Ms. Zhang. After 60 hours of brutal beatings and torture, she was taken to a detention center. While in detention, Ms. Zhang requested that she be sent to a hospital for she kept coughing up blood. The request was denied. The guards force-fed her a concentrated salt solution, and she lost consciousness. They carried her back to her cell, and only much later was she sent to a hospital. Ms. Zhang died from her severe injuries on December 5, 2001.

2. Mr. Song Ruiyi - On the night of his arrest, Mr. Song was handcuffed

with his hands behind his back and was hung up by the handcuffs. The handcuffs cut deeply into his flesh, causing excruciating pain. Later he was taken to another detention center where he went on a hunger strike to protest the abuse. He was force-fed a concentrated salt solution, but he kept up his hunger strike for 14 more days. His stomach was severely damaged by the forced feedings. The center released him after seeing that he was near death. Not long after

his release on December 29, 2001, the police conducted a mass arrest of practitioners. Mr. Song and his wife fled their home. His damaged stomach prevented Mr. Song from eating properly, and he soon became bedridden. He died on November 3, 2002.

3. Mr. Zhang Keming - Mr. Zhang Keming was also tortured the night of his arrest. He was released after 15 days. On December 29, 2001, the police arrested him again. The guards often urged other detainees to beat Mr. Zhang. He soon became emaciated. He was taken to Changlinzi Forced Labor Camp, where he endured severe torture. The guards shocked his sensitive parts with electric batons and deprived him of sleep. He was frequently beaten. Eventually, his whole body was covered with scabies, and his skin festered. The guards injected him with unknown drugs.

On November 9, 2003, not long after Mr. Zhang's release, he was arrested again and detained for 15 days. The relentless persecution caused him enormous stress. He never regained his normal weight. He had severe edema and coughed up blood before he passed away on March 26, 2006. It is suspected that the unknown drugs may have contributed to his symptoms.

Kidney Stones, Liver Cyst Disappear

(Clearwisdom.net) I am a Falun Dafa practitioner in Laizhou, Shandong Province. I used to suffer from many illnesses. After I started to practice Falun Dafa, all my illnesses disappeared. Since then, I have not needed any medicine. To allow me more time to practice Falun Gong, my husband willingly took care of all the chores. He was grateful, for he knew it was Teacher Li Hongzhi and Dafa who had given me a second life.

On July 20, 1999, the Chinese Communist Party (CCP) started its persecution of Falun Dafa. My husband has continued to support me in my practice. The police have often taken me away and extorted money from my family. My husband became very clear about the wickedness of the CCP and the goodness of Dafa. Though he hadn't started to truly practice, he read Teacher's lectures and talked to people about Dafa and exposed the persecution.

In 2005 he was diagnosed with two kidney stones. He was told he needed an operation. My husband did what a practitioner would do and didn't opt for any treatment. In 2007, his health check showed that the kidney stones had disappeared. Later, he was found to have a cyst on his liver, high blood fats, high cholesterol and abnormal heart function. He again didn't opt for any medical treatment. In December 2008, my husband had another checkup. The cyst on his liver had disappeared, and the blood tests, electrocardiogram and other tests were all normal. He phoned me and gleefully told me the results. I asked him, "Do you know why all your illnesses miraculously disappeared?" He answered, "I know very well. A kind thought toward Falun Dafa will bring happiness and peace."
