# Parents Arrested, Three-Year-Old Son Left Behind Unattended

(Clearwisdom.net) Falun Gong practitioners Ms. Lin Xiumei and Mr. Pan Shunyu, a married couple, were illegally arrested on the afternoon of August 3, 2010, by police officers from the Suihua City Police Department, who broke into their home. The couple's three-year-old son was left behind unattended.

Officers ransacked the family's home at the time of arrest, confiscating personal belongings worth over 60,000 yuan (US\$8400) and the house keys. The authorities have refused to return the confiscated keys. Ms. Lin and Mr. Pan are currently detained at the Suihua City Detention Center.

Ms. Lin Xiumei was a computer operator at a management station of the Department of Transportation, in Qing'an County. She started practicing Falun Gong in 1998.

Shortly after the Chinese regime launched the persecution of Falun Gong in July 1999, Ms. Lin was arrested, fined, and put under surveillance. Her home was also ransacked, and she was fired from her job due to her belief in Falun Gong. On September 19, 2001, officers from the Qing'an County Police Department arrested Ms. Lin again and held her in the Shuanghe Labor Camp in Qiqihar, where she was subjected to torture for two years.

### **Two-Year-Old Girl Cries for Her Parents**

(Clearwisdom.net) The little girl in the photo below is named Tian Shengguo and she is two years old. Shengguo's father Mr. Tian Gang, and her mom Ms. Cui Jinglian are both Falun Gong practitioners from Qiqihar City, Heilongjiang Province. Officers from the Jiang'an Police Station in the Longsha District broke into Mr. Tian's tea store and illegally arrested him on March 10, 2010. Mr. Tian was subjected to interrogation and torture for two days. He was later held in the Qiqihar City No.1 Detention Center, and was interrogated and tortured again one week later.

After Mr. Tian's arrest in March, his wife Ms. Cui went to live away from home with their daughter. On July 20, 2010, police officers arrested Ms. Cui. They took her back to Qiqihar, showing no regard for the little girl. That day, Shengguo contracted pneumonia and a fever. Ms. Cui has been held in the Qiqihar City Detention Center ever since her arrest. The authorities now plan to place Ms. Cui on trial.

Little Shengguo now cries every day, longing for her parents.

Falun Gong practitioners set up booths at the two locations, where they introduced Falun Gong, demonstrated the Falun Gong exercises and taught people how to make folded paper lotus flowers. Many people visited the booths on each day of the festival.
